Naturalizations.—The naturalizations effected under the Naturalization Act (R.S.C., 1906, c. 77) for the calendar years 1908-17, inclusive, were given on p. 594 of the Year Book for 1919. Since Jan. 1, 1918, the only method of obtaining naturalization has been under what is known as the "Imperial" Naturalization Act, which came into force on Jan. 1, 1915. This Act was known under the title of the Naturalization Act, 1914, until July 7, 1919, when it was repealed and the Naturalization Act, 1919, came into force. On July 1, 1920, the Naturalization Act, 1919, was repealed, and the Naturalization Act, 1914, was revived and amended under the title of the Naturalization Acts, 1914 and 1920.
