

Chapter 15 (December 20, 1974) *Indian Oil and Gas Act* provides that the Governor in Council may make regulations respecting the disposition of any interest in Indian lands necessarily incidental to the exploitation of oil and gas, and regulations prescribing the royalties obtained on the oil and gas; and provides for a special agreement, with the approval of the band council concerned, for a reduction or an increase of such royalties.

Chapter 16 (December 20, 1974) *An Act respecting the office of the Secretary to the Cabinet for Federal-Provincial Relations and respecting the Clerk of the Privy Council* provides for the appointment of the Secretary to the Cabinet for Federal-Provincial Relations and alters the designation Clerk of the Privy Council to Clerk of the Privy Council and Secretary to the Cabinet.

Chapter 17 (December 20, 1974) *An Act to amend the Export Development Act* allows for an increase in the authorized share capital, in the borrowing capacity and in the maximum potential liability of the Export Development Corporation; allows for an increase in the maximum liability of foreign customers to the corporation; permits the corporation to enter into re-insurance contracts; and provides for other related and consequential amendments.

Chapter 18 (December 20, 1974) *An Act to amend the Supreme Court Act and to make related amendments to the Federal Court Act* modifies the residence requirement for the judges, Registrar and Deputy Registrar of the Supreme Court of Canada, changing references to Ottawa to the National Capital Region; eliminates appeals to the Supreme Court from judgments; and specifies criteria to be taken into account by the Supreme Court in determining whether or not to allow appeals to that court.

Chapter 19 (December 20, 1974) *An Act to revise references to the Court of Queen's Bench of the Province of Quebec* effects the necessary changes in federal statutes to reflect the abolition of the Court of Queen's Bench in the province of Quebec.

Chapter 20 (December 20, 1974) *Statute Revision Act* provides for a continuing revision and consolidation of the statutes and regulations of Canada.

Chapter 21 (December 20, 1974) *Appropriation Act No. 4, 1974* grants certain sums of money for the public service for the financial year ending March 31, 1975.

Chapter 22 (December 20, 1974) *Appropriation Act No. 5, 1974* grants certain sums of money for the public service for the financial year ending March 31, 1975.

Chapter 23 (February 2, 1975) *An Act to amend the Customs Tariff (No. 2)* re-introduces a number of temporary tariff reductions for the period November 19, 1974 to June 30, 1976.

Chapter 24 (February 27, 1975) *An Act to amend the Excise Tax Act and the Excise Act* imposes air transportation taxes on regular and charter flights; affects taxes levied in areas such as the sale and resale of goods by licensed wholesalers operating duty-free outlets; increases the special excise tax on wines; increases the excise duties on spirits, brandy, tobacco, cigarettes and cigars; exempts from sales tax certain medical goods, bicycles, transportation and construction equipment and footwear; reduces the sales tax on construction materials and equipment for buildings; imposes a special excise tax on transportation vehicles; and re-instates the sales tax on printed matter produced by government for government use.

Chapter 25 (February 27, 1975) *An Act to amend the Electoral Boundaries Readjustment Act* modifies one of the rules regarding the make-up of electoral boundaries.

Chapter 26 (February 27, 1975) *An Act to amend the statute law relating to income tax* provides for changes in personal and corporate income tax.

Chapter 27 (March 13, 1975) *An Act to amend the Canadian Wheat Board Act* provides that final payments on deliveries of wheat in any pool period shall not be made until on or after January 1 of the calendar year following the end of the pool period.

Chapter 28 (March 13, 1975) *Northwest Territories Representation Act* increases the representation of the Northwest Territories in the House of Commons from one to two members and establishes a commission to readjust the electoral boundaries of the Northwest Territories.

Chapter 29 (March 13, 1975) *An Act respecting the Electoral Boundaries Readjustment Act* changes the name of the electoral district of Bruce in Ontario to Bruce-Grey.
