does not appear or remain in attendance at his trial; and clarifies the procedure for dealing with persons in custody who are mentally ill.

Chapter 94 (March 30, 1976) An Act to amend the Feeds Act broadens and clarifies the definition of "feed" and "livestock" and provides for greater control over the manufacture, sale or importation into Canada of feeds.

Chapter 95 (May 5, 1976) Compensation for Former Prisoners of War Act provides for compensation for former defined prisoners of war and their dependents and consequentially amends certain other statutes.

Chapter 96 (May 5, 1976) Motor Vehicle Tire Safety Act provides for the use of national safety marks in relation to motor vehicle tires and provides for safety standards for certain motor vehicle tires imported into or exported from Canada or sent or conveyed from one province to another.

Chapter 97 (May 5, 1976) An Act to amend the Quarantine Act provides legislative authority for taking prompt and appropriate action in emergency situations at Canadian ports of entry to prevent the importation into Canada of dangerous diseases not presently covered by the act.

Chapter 98 (May 20, 1976) An Act to amend the Anti-Inflation Act requires that the Anti-Inflation Board refer to the administrator any increase in prices, profits, compensation or dividends under certain conditions; increases the range of optional orders that the administrator could make in compensation and dividend cases; permits members of the Tax Review Board to serve as members of the Anti-Inflation Appeal Tribunal; limits the cases in which payment to the Receiver General or provision of security precedes the hearing of an appeal; and requires the concurrence of the Senate in any motion to terminate the Anti-Inflation Act.

Chapter 99 (June 15, 1976) An Act to amend the Senate and House of Commons Act and the Supplementary Retirement Benefits Act with respect to the escalation of certain payments thereunder prescribes a delay until 1977 in the payment of the extra salaries and allowances over and above the sessional allowances, and delays until 1977 the escalation of the sessional allowances; and temporarily limits the supplementary retirement benefits payable to members of the Senate and the House of Commons.

Chapter 100 (June 15, 1976) An Act to amend the Aeronautics Act permits regulations to be made requiring foreign air carriers operating into or from airports in Canada to carry out a security program with respect to passengers and goods similar to the security program required to be carried out by Canadian air carriers.

Chapter 101 (June 15, 1976) An Act to amend an Act to Repeal the Proprietary or Patent Medicine Act and to amend the Trade Marks Act alters the expiry date of licences to sell proprietary or patent medicine, granted in the year 1976, from December 31, 1976 to March 31, 1977.

Chapter 102 (June 29, 1976) Appropriation Act No. 3, 1976 grants certain sums of money for the public service for the financial year ending March 31, 1977.

Chapter 103 (June 29, 1976) Appropriation Act No. 4, 1976 grants certain sums of money for the public service for the financial year ending March 31, 1977.

Chapter 104 (June 29, 1976) An Act to implement conventions for the avoidance of double taxation with respect to income tax between Canada and France, Canada and Belgium and Canada and Israel.

Chapter 105 (July 16, 1976) An Act to amend the Criminal Code in relation to the punishment for murder and certain other serious offences removes the death penalty from the Criminal Code in Canada in relation to the punishment for murder and certain other offences such as treason and high treason.

Chapter 106 (July 16, 1976) An Act to amend the Income Tax Act disallows deductions for the cost of advertising space in non-Canadian newspapers or periodicals directed primarily to a market in Canada and disallows deductions for an advertisement broadcast by a broadcasting undertaking located outside Canada and directed primarily to a market in Canada.

Chapter 107 (July 16, 1976) An Act to amend the Medical Care Act limits the annual increase in the per capita cost of all insured services for specified years pursuant to medical care insurance plans of participating provinces.

Chapter 108 (July 16, 1976) Citizenship Act replaces the Canadian Citizenship Act of 1947. Among other provisions, it shortens the length of residence in Canada prior to application for citizenship from five to
