

receives \$9,102 plus an office allowance of \$17,500 per annum, the speaker \$6,535 and the deputy speaker \$3,925.

Each member of the legislature is paid an annual indemnity of \$7,840, an expense allowance of \$7,000 and a sessional allowance of \$3,270. Each of the members for the two northernmost constituencies of Athabasca and Cumberland receives an \$8,840 annual indemnity and a \$7,250 expense allowance. Government and opposition whips are paid an annual allowance of \$1,310 each and legislative secretaries an annual allowance of \$3,000 each. The third party whip is paid an annual allowance of \$708.

**Alberta**

**3.3.1.9**

In addition to the lieutenant-governor (since April 1974 the Honourable Ralph Steinhauer) the government of Alberta is composed of an executive council and a Legislative Assembly of 75 members elected for a maximum of five years. On March 26, 1975, 69 Progressive Conservatives, four members of the Social Credit party, one of the New Democratic Party and one Independent-Social Credit member were elected to form the 18th Legislature.

Each member of the Legislative Assembly receives a sessional indemnity of \$12,469, a \$6,234 expense allowance and an amount not to exceed \$40 for each day during the session when the member is necessarily absent from his ordinary place of residence. In addition to the indemnity and expense allowance, the speaker receives a salary of \$18,500 and the deputy speaker \$6,735. The salary of the leader of the opposition, in addition to the indemnity and expense allowance, is \$30,483. The speaker, deputy speaker and leader of the opposition also receive an amount not to exceed \$40 for each day during the session when they are necessarily absent from their ordinary place of residence. In addition to the sessional indemnity and allowance the premier receives \$37,410, other ministers \$30,483 and ministers without portfolio \$22,169. These figures have been in effect since April 1, 1978.
